The HELICOPTER project is still in its initial phases, with neither due deliverables nor milestones to be achieved in the reporting period.

The project proceeded as planned, focusing mostly at initial studies and at the development of components of the envisaged HELICOPTER system. Cooperation among the partnership is effectively started.

With reference to the proposal workplan, activities were started in all workpackages, except for WP5 (which deals with pilots).

In particular, WP2 (User-Centered Design Research) focused on methodological aspects so far, establishing first contacts with end-users and planning project interaction strategies.

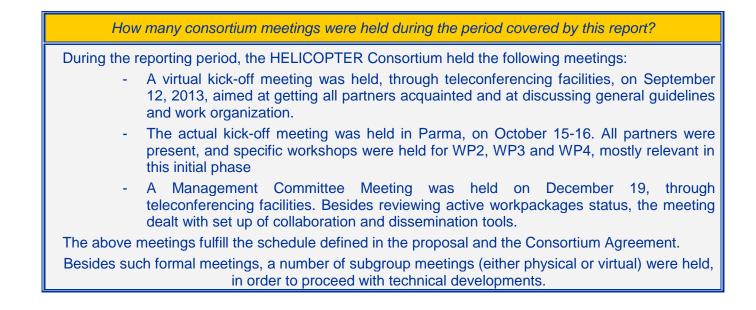
WP3 mainly dealt with elemental components of the sensor network: most relevant effort, besides identifying off-the-shelf sensors to be incorporated into the Helicopter frame, was devoted at the user identification issue: i.e., within a multi-user environment, the need arise of associating indirect information coming from environmental sensors to a given user, without asking the user for any identification task. This implies localization features to be included into the wireless network, which are being developed in a lightweight, unobtrusive fashion.

WP4 (Models) required an intense interaction among partners, in order to provide a reliable domain definition and to start building the Helicopter system ontology. Tools and procedures for managing the interaction among partners were successfully introduced, needed to make such a crucial issue participated by all partners as much as possible.

Up to now, no need of meaningful deviation from the original workplan was devised. First actual tangible outcomes from all workpackages are expected for incoming months.
